A high school student admitted under the provisions set forth below may enroll in a combined number of high school and college courses per semester not to exceed a full-time college work load of 19 semester credit hours. A high school student may enroll in a maximum of 9 semester credit hours during a summer session. A high school student must meet the following requirements for admission:

To continue enrollment in following semesters, high school students concurrently enrolled in college courses must maintain a college cumulative GPA of 2.0 or above on a 4.0 scale.

In conjunction with the Oklahoma State Regents for High Education, Northeast Oklahoma A&M College continues to participate in the program for concurrent enrollment. NEO will provide tuition waivers to all high school students for the summer, fall and spring semesters. Under this program, high school students are eligible to receive a resident tuition waiver for up to six (6) credit hours per semester. Any remaining tuition, fees and book cost must be paid by the student. To retain, this tuition waiver, recipients must maintain a grade point average of 2.00.

I certify that this student is eligible to satisfy requirements for graduation from high school (including curricular requirements for college admission) no later than the spring of their senior year. I have reviewed this student's academic records and have met with the student and determined that he is a good candidate for the concurrent high school program.
